

# II May Right Cinema Fest

## Regulations

### **1. General information**

The II May Right Cinema Fest will take place from April 30 to May 10, 2023 in Moscow

- 1.1. The II May Right Cinema Fest (hereinafter – the Festival) will be held from April 30 to May 10, 2023 in Moscow and the regions of the Russian Federation.
- 1.2. The festival is timed to the celebration of Victory Day.
- 1.3. Main Organizer of Festival: Victory Museum

### **2. Goals and objectives.**

- 2.1. Promotion of patriotic education.
- 2.2. Introducing the younger generation to the study of the history of our Fatherland, the history of wars and the participation of Russian (Soviet) soldiers in them.
- 2.3. Familiarization of citizens with new films and their authors.
- 2.4. Expanding the audience of films by showing them on public platforms.
- 2.5. Strengthening the cultural, educational and informational functions of cinema.

### **3. The Directorate.**

- 3.1. The Festival Organizers form the Festival Directorate.
- 3.2. Functions of the Directorate:
  - formation of the Selection Committee of the Festival;
  - organization of film screenings, master classes, creative meetings, round tables;
  - organization of the Festival's advertising campaign;
  - preparation of information materials of the Festival;
  - moderation of the Festival section on the website of the Poklonka cinema.
- 3.3. The Festival director is the Head of the Poklonka cinema, Lara Pomykanova.

### **4. Festival Programs.**

- 4.1. Non-competitive program of films dedicated to famous characters who have contributed to the history and development of the country;
- 4.2. Non-competitive program of films dedicated to the feat of Russian citizens;
- 4.3. Animation program;
- 4.4. Retrospective screenings.

### **5. Participation in the Festival.**

5.1. To participate in the selection for the Festival program, fiction, animated and documentary feature-length and short films of Russia, CIS and other countries, produced in 2020 - 2023, are accepted.

5.2. To participate in the selection, it is necessary to fill in an application on the official website of the Poklonka cinema by March 20, 2023. Films sent after the specified date would not be accepted. The application must contain a closed link to the viewing copy of the film on vimeo.com or youtube.com (the link must be valid until the end date of the Festival).

***By submitting an online application and pre-selection online screener for the Festival, the submitter confirms the full acceptance of the festival's rules and regulations and declares an agreement of film screening at the Festival.***

5.3. The order of showing films at the Festival is determined by the Festival Directorate.

5.4. The Festival Management does not take on its account the costs of the stay (travel, accommodation, meals) of the Festival participants.

## **6. Copies of films to be shown at the Festival.**

6.1. Copies of films selected for screening in the Festival programs must be submitted to the Festival Directorate no later than April 10, 2023. Full-length feature films, animated films and documentaries are accepted in DCP format, short films in mp4 format.

6.2. If the DCP copy is encrypted, the Festival Directorate must be provided with a key to the entire duration of the Festival.

6.3. If it is not possible to transfer a copy of the film within the specified time, the Participant should negotiate possible methods of transfer with the Festival Directorate.

## **7. Prizes.**

7.1. According to the results of the online voting of the audience, the winners in each program will be determined.

7.2. Special prizes from the Festival partners.

## **8. Film festival venues.**

8.1. Poklonka Cinema, address: 3 Ploschad Pobedy, Moscow

8.2. More than 250 museums of Russia and CIS countries, various departmental affiliation, patriotic non-profit organizations and educational centers and schools.

## **9. Final provisions.**

9.1. The Festival Organizer guarantees that it will not use and transfer films to third parties for commercial purposes, and reserves the right to use photographs, slides and fragments of films (lasting no more than 3 minutes) for publications in the media.

9.2. Each participant of the Festival who provides a film for participation in the Festival guarantees that:

- 9.2.1. has all the rights (possession of exclusive rights or the appropriate permission of the copyright holder) to provide such a film to the Festival. The responsibility for possible claims and claims of third parties related to copyright and related rights lies with the participant of the Festival who sent his application and the film. In case of claims by third parties regarding the ownership of the rights to the films provided for participation in the Festival, the Festival Organizer reserves the right to remove the participant's film from consideration and from the Festival programs at any stage until all the circumstances are clarified.
- 9.2.2. the film does not contain information, the distribution of which is prohibited by the legislation of the Russian Federation, does not contain obscene language;
- 9.3. The Festival organizers reserve the right to non-commercial screenings of films sent to participate in the Festival during 2023 at the end of the Festival and the "Echo" of the Festival (in agreement with the copyright holders of such films).
- 9.4. The Festival Directorate reserves the right not to explain the reason for the refusal to include the film in the Festival program and not provide comment on this decision.
- 9.5. The Festival Organizers reserve the right to make changes to the guiding rules of the Festival during the preparation for its holding.
- 9.6. Participation in the Festival implies agreement with its Regulations.
